Time	: 11.30 a.m. or immediately after the conclusion or adjournment (as the case may be) of the Company's 19th Annual General Meeting, scheduled to be held at the same venue on the same day at 10.00 a.m., whichever is the later or at any adjournment thereof

**REGISTRATION**

1. Registration will commence at 9.00 a.m. and will remain open until the conclusion of the EGM or such time as may be determined by the Chairman of the meeting.
2. Shareholders or proxies are required to produce/show their original MyKAD or Passport (for non-Malaysians) to the registration staff for verification purposes. Please ensure the original MyKAD or Passport is returned to you thereafter. Please take note that registration on behalf of another person is not permitted, even with that person's original MyKAD or Passport.
3. Upon verification, shareholders or proxies will also be issued an identification wristband for voting purpose. No person will be allowed to enter the meeting hall without the identification wristband. No replacement wristband will be provided in the event it is lost or misplaced.

**CORPORATE MEMBERS**

1. Corporate members who wish to appoint corporate representative instead of a proxy must deposit their original or duly certified certificate of appointment of corporate representative with Tricor Investor & Issuing House Services Sdn. Bhd. (“TIIH”) on or before the EGM.
2. Attorneys appointed by power of attorney are required to deposit their power of attorney with TIIH not later than Saturday, 27 June 2026 at 11.30 a.m. to attend and vote at the EGM.

**PROXY**

The appointment of proxy may be made in hard copy form or by electronic means in the following manner and must be received by the Company at least forty-eight (48) hours before the time appointed for holding the EGM or at any adjournment thereof, otherwise the proxy form shall not be treated as valid:

**PROCEDURE FOR ELECTRONIC LODGEMENT OF PROXY FORM**

The procedures to submit your proxy form electronically via the **Portal** website are summarised below:

<p>Register as a User at the Portal</p>	<ol style="list-style-type: none"> <li>1. Visit the website at <a href="https://srmy.vistra.com">https://srmy.vistra.com</a>.</li> <li>2. Click "Register" and select "Individual Holder", then complete the New User Registration Form.</li> <li>3. For guidance, you may refer to the tutorial guide available on the homepage.</li> <li>4. Once registration is completed, you will receive an email notification to verify your registered email address.</li> <li>5. After verification, your registration will be reviewed and approved within one (1) working day. A confirmation email will be sent once approved.</li> <li>6. Upon receiving the confirmation email, activate your account by creating a password.</li> </ol> <p><i>If you are an existing user with the Portal or had registered with TIH Online portal previously, you are not required to register again.</i></p>
<p>Proceed with submission of proxy form</p>	<ol style="list-style-type: none"> <li>1. After the release of the Notice of Meeting by the Company, login to the Portal with your email address and password.</li> <li>2. Select the corporate event: "<b>SIGNATURE INTERNATIONAL BERHAD EGM 2026</b>".</li> <li>3. Navigate to the 3 dots at the end of the corporate event and choose "<b>SUBMISSION OF PROXY FORM</b>".</li> <li>4. Read and agree to the Terms and Conditions and confirm the Declaration.</li> <li>5. Indicate the total number of shares assigned to your proxy(s) to vote on your behalf.</li> <li>6. Appoint your proxy(ies) and insert the required details of your proxy(ies) or appoint the Chairman of the meeting as your proxy.</li> <li>7. Indicate your voting instructions – FOR or AGAINST, otherwise your proxy will decide on your votes.</li> <li>8. Print the proxy form for your record.</li> </ol>
<p><b>ii. <u>Steps for Corporation or Institutional Shareholders</u></b></p>	
<p>Register as a User at The Portal</p>	<ol style="list-style-type: none"> <li>1. Visit the website at <a href="https://srmy.vistra.com">https://srmy.vistra.com</a>.</li> <li>2. Click "Register" and select "Representative of Corporate Holder" and complete the New User Registration Form.</li> <li>3. Complete the registration form with your personal details.</li> <li>4. Once registration is completed, you will receive an email notification to verify your registered email address.</li> <li>5. After verification, your registration will be reviewed and approved within two (2) working days. A confirmation email will be sent once approved.</li> <li>6. Upon receiving the confirmation email, activate your account by creating a password.</li> </ol>

	<i>Note: The representative of a corporation or institutional shareholder must register as a user in accordance with the above steps before he/she can subscribe to this corporate holder electronic proxy submission. Please contact Tricor if you need clarifications on the user registration.</i>

Login to the Portal at <a href="https://srmy.vistra.com">https://srmy.vistra.com</a> with your email address and password.</li> <li>2. Select the corporate event: “<b>SIGNATURE INTERNATIONAL BERHAD EGM 2026</b>”.</li> <li>3. Navigate to the icon “&gt;” at the end of the corporate event.</li> <li>4. Read and agree to the Terms and Conditions and confirm the Declaration.</li> <li>5. Select the corporate holder’s name.</li> <li>6. Proceed to download the submission file.</li> <li>7. Prepare the file for the appointment of proxy(ies) by inserting the required data.</li> <li>8. Proceed to upload the duly completed proxy appointment file.</li> <li>9. Select “<b>Confirm</b>” to complete your submission.</li> <li>10. Print the confirmation report of your submission for your record.</li> </ol>

If you wish to participate in the EGM, please do not submit any proxy form for the EGM. You will not be allowed to participate in the EGM together with the proxy(ies) appointed by you.

**ENTITLEMENT TO PARTICIPATE / GENERAL MEETING RECORD OF DEPOSITORS (“ROD”)**

Only a shareholder whose name appears in the ROD of the Company as at **22 June 2026** shall be entitled to attend, speak and vote at the EGM or appoint proxies to attend and/or vote on his/her behalf.

**NO DOOR GIFT / FOOD VOUCHER**

No door gifts or food vouchers will be provided to shareholders/ proxies/ authorized representatives/ attorneys attending the EGM.

**NO RECORDING OR PHOTOGRAPHY**

No recording or photography of the proceedings of the EGM is allowed without the prior written consent of the Company.
